This is the date and time set for a motion hearing of the Defendant, Cody Klotz, with the Honorable Robert G. Olson presiding. This hearing was held in open court in the Teton County Courtroom. Mr. Joe Coble appeared on behalf of the Plaintiff. The Defendant was present and was represented by his lawyer, Meghan Lulf Sutton.

The State and Defense have filed motions that are before the Court and part of the record.

A Plea Agreement has been negotiated which will be presented to the Court.

The Court understood that the Defendant would be pleading guilty to 3 misdemeanor charges.

The Defense would like sentencing to be on a later date.

The Defendant stated his full name is Cody Klotz; he is not under the influence of alcohol and has not taken any medication that would affect his judgment or understanding of these proceedings.

The Court advised the Defendant of his rights; the Defendant understands his rights.

The plea agreement was read and signed by the State and Defendant.

The Defendant stated that he understood what the content of what the Plea Agreement is.

The Court advised the Defendant of the rights he is giving up by entering a plea of guilty.

With respect to Count II, IV and V of the Information, the Defendant changed his plea to guilty.

The Defendant stated that no one has promised him anything or offered him anything to change his plea.

The Defendant was duly sworn, and Ms. Lulf Sutton provided a factual basis for the underlying charges. The Court and the State were satisfied with the factual basis. Based on the testimony provided, the Court accepted the Defendant's plea of guilty.

The Court set a sentencing hearing for Tuesday August 27, 2019 at 10:00 a.m.

The Conditions of Bond as previously ordered are still in effect and the Defendant understands & acknowledges that bond will be revoked if rules are not followed.
